**Applications for Visiting Professor Scholarship in Brazil of the CAPES-Print Program of the Graduate Urbanism Program - PROURB-FAU / UFRJ**

1. PRESENTATION

Based on Notice no.41 / 2017 - Amendment VI / 2018 (Capes-Print Program) and Ordinances n° 01/2020 and n° 289, of 28 December 2018, the Coordination of the Graduate Program in Urbanism at the Federal University of Rio de Janeiro - PROURB-FAU / UFRJ – informs that registration for applications for Visiting Professor scholarships in Brazil under the Institutional Program of Internationalization - Capes-Print UFRJ - will be open from June 26<sup>th</sup> to July 20<sup>th</sup>, 2023.

This application will compose a waiting list for UFRJ similar scholarships, for stays of 15 days each, starting from 01/10/2023 to 31/12/2023. The dates in the application documents should follow the CAPES for 15-days scholarships, for instance from 01/10/2023 to 15/10/2023. After implementation, the beneficiary may ask CAPES to alter the specific dates, as long as the period starts within the aforementioned range (from 01/10/2023 to 31/12/2023).

The Committee designated by PROURB-FAU / UFRJ will make the selection of candidates for the scholarship, and the Program will be responsible for meeting and analyzing the documentation required by Capes, respecting the requirements established by this funding agency.

Proposals should be submitted according to the documentation required below, by July 20<sup>th</sup>, 2023, 6 p. m (GMT -3).

The Visiting Professor in Brazil modality aims at conducting courses, training, lectures or face-to-face seminars, as well as the development of research activities in the Graduate Program in Urbanism - PROURB / FAU / UFRJ.

2. REQUIRED DOCUMENTATION

The following documents are required for this Notice, which should be submitted in electronic version:

- 2.1. Document certifying residency and link with a teaching and / or research institution abroad;
- 2.2. Curriculum vitae;
- 2.3. Updated ORCID record;
- 2.4. Working plan to be developed during the stay in Brazil, comprising the following items:
  - Activities to be developed (courses, training, lectures or face-to-face seminars);
  - Justification, highlighting that the theme is relevant and contemporary, as well as its adherence to the Institutional Project for Internationalization at UFRJ;

- Clear definition and delimitation of the study object (s) to be approached in the activities;
- Goals and objectives;
- Activities timetable.

For submission, all documents mentioned in item 2 of this Notice should be attached as files in PDF format, so that each document corresponds to a single file.

### 4. VACANCIES

Approved candidates will compose a waiting list. The grant includes airplane ticket and a scholarship for the 15 days of stay. It will be up to PR-2 to confirm the allocation of the scholarship(s), appointing the candidates among those indicated by the Graduate Programs at UFRJ.

### 5. SELECTION AND CLASSIFICATION PROCESS

5.1 - The Evaluation Committee, appointed by the PROURB Collegiate, is composed of the following academic staff: Rodrigo Cury Paraizo (PROURB-FAU-UFRJ Coordinator), Denise Barcellos Pinheiro Machado (PROURB-FAU-UFRJ Lecturer), and Maria Beatriz Afflalo Brandão (External Lecturer).

5.2 - The selection process steps will consist of:

Analysis of the Curriculum Vitae, with an emphasis on scientific production in the area of Urbanism; Analysis of the Working Plan, evaluating its importance and the possibilities of expanding international exchange and cooperation for PROURB.

### 6. OUTCOMES AND CLASSIFICATION

The internal final result will be approved by the Collegiate of the Graduate Program in Urbanism and published according to the Timetable indicated below. The documents necessary for the implementation of the scholarship must be sent to PROURB within the period established by the Timetable and failure to comply with this period will result in loss of the right to a vacancy.

In the final disclosure of the outcomes of the selection process, the name of all the classifieds will appear in descending order of classification.

The omitted cases in this Notice will be solved by the Selection Committee defined by the Collegiate of the Graduate Program in Urbanism.

THEME: Sustainability, Growth and Combating Inequalities

Justification of the Sustainability, Growth and Actions against Inequalities Theme

Such investigations and actions, developed in different fields of knowledge, respond to Brazilian and different countries' demands, and aim to promote the production of Sustainability, Growth and Actions Against Inequalities.
